HO-CHUNK NATION LEGISLATURE AUTHORIZING CONTRACTS FOR HILL INTERNATIONAL, INC. & HNEDEK BOBO GROUP

RESOLUTION 04-22-14G

WHEREAS, on November 1, 1994, the United States Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and

WHEREAS, the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934; and

WHEREAS, the Legislature of the Ho-Chunk Nation ("Legislature") is the duly constituted governing body of the Nation pursuant to the Constitution of the Ho-Chunk Nation ("Constitution"); and

WHEREAS, Article V, Section 2(a) of the Constitution grants the Legislature the power to make laws, including codes, ordinances, resolutions, and statutes; and

WHEREAS, Article V, Section 2(d) of the Constitution grants the Legislature the power to authorize expenditures by law and appropriate funds to the various Departments in an annual budget; and

WHEREAS, Article V, Section 2(i) of the Constitution grants the Legislature the power to negotiate and enter into treaties, compacts, contracts, and agreements with other governments, organizations, or individuals; and

WHEREAS, Article V, Section 2(l) of the Constitution grants the Legislature the power to enact laws to manage, lease, permit, or otherwise deal with the Nation's lands, interests in lands or other assets; and

WHEREAS, the Ho-Chunk Nation Office of the President, Department of Business, and Department of Treasury would like to enter into a contracts with Hill International, Inc. as the Nation's Owner's Representative and Hnedek Bobo Group as the Architect and Design firm for the Community Reinvestment projects that the Legislature approved by Resolution 3-7-14B at a Special Meeting; and

WHEREAS, the Department of Business and Department of Treasury have reviewed and analyzed the proposed contracts and are in support of entering into the contracts.

NOW THEREFORE, BE IT RESOLVED that the Ho-Chunk Nation Legislature hereby approves the Hill International, Inc. and Hdenek Bobo Group contracts; and

BE IT FURTHER RESOLVED that the Ho-Chunk Nation Legislature hereby grants the Vice-President signature authority for the Hill International, Inc. and Hdenek Bobo Group contracts; and

BE IT FURTHER RESOLVED that the Ho-Chunk Nation Legislature hereby grants the President signature authority for any contracts hereafter associated with the Hill International, Inc. and Hdenek Bobo Group contracts that do not exceed \$100,000.
