### **HO-CHUNK NATION LEGISLATURE DENIAL OF ROGER THUNDERCLOUD AS DISTRICT 3 ETHICS REVIEW BOARD MEMBER**

#### **RESOLUTION 06-03-14N**

- WHEREAS**, on November 1, 1994, the United States Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and
- WHEREAS**, the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, pursuant to the Indian Reorganization Act of 1934; and
- WHEREAS**, Article V, Section 2(a) of the Ho-Chunk Nation Constitution ("Constitution") gives the Ho-Chunk Nation Legislature ("Legislature") the power to make laws, including codes, ordinances, resolutions, and statutes; and
- WHEREAS**, Article V, Section 2(f) of the Constitution grants the Legislature the power to set the salaries, terms and conditions of employment for all governmental personnel; and
- WHEREAS**, Article V, Section 2(h) of the Constitution grants the Legislature the power to enact all laws prohibiting and regulating conduct, and imposing penalties upon all persons within the jurisdiction of the Nation; and
- WHEREAS**, Article V, Section 2(r) of the Constitution requires the Legislature to protect and foster Ho-Chunk religious freedom, culture, language, and traditions; and
- WHEREAS**, Article V, Section 2(x) of the Constitution grants the Legislature the power to enact any other laws, ordinances, resolutions, and statutes necessary to exercise its legislative powers delegated by the General Council pursuant to Article III including but not limited to the foregoing list of powers; and
- WHEREAS**, Article V, Section 3 of the Constitution provides that the Legislature shall adopt Codes governing Membership, Open Meetings, Elections, and Ethics, including conflicts of interest, nepotism, and the conduct of all elected and appointed officials and employees; and

**WHEREAS,** the Legislature adopted the Nation's Code of Ethics on January 12, 1999 through Resolution 01-12-99A and has since placed the Code out for public comment and amended the law to address inconsistencies, funding needs and Ethics Review Board membership; and

**WHEREAS,** the Code of Ethics Act establishes an Ethics Review Board, consisting of 14 members, whose purpose is to hear and consider reports or complaints of alleged violations under the Code of Ethics Act; and

**WHEREAS,** under the Code of Ethics Act, members of the Ethics Review Board are subject to confirmation by the Legislature after nomination by each Ho-Chunk Nation District, and upon satisfactory completion of a background investigation; and

**WHEREAS,** the Legislature finds that the District 3 nominee for the Ethics Review Board, Roger Thundercloud, does not meet the qualifications for membership on the Board under the Code of Ethics Act; and

**WHEREAS,** the Legislature having received and reviewed a background investigation finds Roger Thundercloud unsuitable to serve on the Ethics Review Board.

**NOW THEREFORE, BE IT RESOLVED** that the Legislature, pursuant to its Constitutional authority and the Code of Ethics Act, hereby denies Roger Thundercloud as the District 3 member of the Ethics Review Board.

#### **CERTIFICATION**

I, the undersigned, as Tribal Secretary of Ho-Chunk Nation, hereby certifies that the Legislature of the Ho-Chunk Nation, composed of 13 members of whom 12 constituting a quorum were present at a meeting duly called and convened and held that on the 3<sup>rd</sup> day of June, 2014, that the foregoing resolution was adopted at said meeting by an affirmative vote of 12 members, 0 opposed, and 0 abstaining, pursuant to the Article V, Section 2(a) through (x) of the Constitution of the Ho-Chunk Nation approved by the Secretary of the Interior on November 1, 1994, and that the foregoing resolution has not been rescinded or amended in any way. I further certify that this is a verified copy of said resolution.
