HO-CHUNK NATION LEGISLATURE 2013-2016 TRANSPORTATION IMPROVEMENT PLAN AMENDMENT

RESOLUTION 06-18-13C

WHEREAS, on November 1, 1994, the United States Secretary of Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Nation, and

WHEREAS, the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, organized pursuant to the Indian Reorganization Act of 1934; and

WHEREAS, the Legislature of the Ho-Chunk Nation ("Legislature") is the duly constituted governing body of the Ho-Chunk Nation pursuant to the Constitution of the Ho-Chunk Nation ("Constitution"); and

WHEREAS, Article V, Section 2 (a) of the Constitution grants the Legislature the power to make laws, including codes, ordinances, resolutions, and statutes, and

WHEREAS, Article V, Section 2, (i) of the Constitution authorizes the Legislature to negotiate and enter into treaties, compacts, contracts, and agreement with other governments, organizations, or individual; and

WHEREAS, the Ho-Chunk Nation recognizes adequate and safe road infrastructure is critical to all Tribal development; and

WEHREAS, the Bureau of Indian Affairs shares responsibility for developing and maintaining roads on Indian lands; and

WEHREAS, the Ho-Chunk wishes to update its Tribal Transportation Improvement Plan to address the critical need for expanded and improved road infrastructure for a rapidly developing Tribal community.

NOW THEREFORE IT BE RESOLVED, that the Ho-Chunk Legislature, hereby request the Bureau of Indian Affairs to update the roads listed in the attachment to the Ho-Chunk Nation Tribal Transportation Improvement Plan.

BE IT FURTHER RESOLVED, that the attached Tribal Transportation Improvement Plan List be updated as Exhibit D and is to be included in the annual update of the Long Range Transportation Plan.
