SUBSECTION 3 (6 HCC § 8-3) – HAZARD COMMUNICATION,
OUT FOR FORTY-FIVE DAY PUBLIC COMMENT**

RESOLUTION 10-21-14H

WHEREAS, on November 1, 1994, the Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Nation; and

WHEREAS, the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, organized and established pursuant to the Indian Reorganization Act of 1934; and

WHEREAS, the Ho-Chunk Nation Legislature ("Legislature") is the duly constituted governing body of the Nation to the Ho-Chunk Nation Constitution ("Constitution"); and

WHEREAS, Article V, Section 2(a) of the Constitution of the Ho-Chunk Nation ("Constitution") grants the Legislature the power to make laws, including codes, ordinances, resolutions, and statutes; and

WHEREAS, Article V, Section 2(f) of the Constitution of the Ho-Chunk Nation ("Constitution") grants the Legislature the power to set salaries, terms and conditions of employment for all governmental personnel; and

WHEREAS, Article V, Section 2(h) of the Constitution grants the Legislature the power to enact all laws prohibiting and regulating conduct, and imposing penalties upon all persons within the jurisdiction of the Nation; and

WHEREAS, Article V, Section 2(s) of the Constitution grants the Legislature the power to promote public health, education, charity, and such other services as may contribute to the social advancement of the members of the Ho-Chunk Nation; and

WHEREAS, Article V, Section 2(x) of the Constitution grants the Legislature the power to enact any other laws, ordinances, resolutions, and statutes necessary to exercise its Legislative powers delegated by the General Council pursuant to Article III including but not limited to the foregoing list of powers; and

WHEREAS, the Ho-Chunk Nation Legislature passed the *Legislative Organization Act* (2 HCC § 11), which was last amended on January 21, 2014; and

WHEREAS, the *Legislative Organization Act* provides the procedures for enacting or amending a Ho-Chunk Nation Law; and

WHEREAS, section 30, subparagraph k (1) (a) of the *Legislative Organization Act* provides that the Public review period of a law will typically be forty-five (45) day; and

WHEREAS, the Legislature enacted the Occupational Safety and Health Program Act of 2002 (Act) by Resolution 05-20-02E; and

WHEREAS, the Legislature set various terms and conditions for occupational safety and health for the Nation by adopting the Nation's Occupational Safety and Health Program Act (6 HCC § 8), which contains subsection 3 – Hazard Communication; and

WHEREAS, the Labor Department (Safety Division) Review Committee met several times to review the subsection ordinances, discuss and update any necessary revisions to Subsection 3 – Hazard Communication to improve its coverage and application for the Nation and all its entities; and

WHEREAS, the Review Committee included the Department of Labor Safety Division and Executive Director; and

WHEREAS, after final review of the Subsection 3 – Hazard Communication, a draft working document, showing proposed amendments, has been created and is ready for distribution to the public for comment; and

WHEREAS, the Nation's Occupational Safety and Health Division has recommended changes to the ordinance to provide new and updated language and terminology that meets the current federal standard; and

WHEREAS, the Legislature finds it appropriate to place the proposed amendments to the Subsection 3 – Hazard Communication Ordinance out for comment pursuant to the procedures of the Legislative Organization Act.

NOW THEREFORE, BE IT RESOLVED, that the Ho-Chunk Nation Legislature, pursuant to its constitutional authority, places the amendments proposed to the Occupational Safety and Health Program Act Subsection 3 – Hazard Communication by the Labor Department Review Committee out for forty-five (45) day public comment.

CERTIFICATION
