### **HO-CHUNK NATION LEGISLATURE UNEXPENDED FUNDS APPROPRIATION FOR THE DEPARTMENT OF BUSINESS WHITETAIL CROSSING TO PURCHASE VEEDER ROOT TANK GAUGES**

#### **RESOLUTION 10-21-14N**

**WHEREAS,** on November 1, 1994, the United States Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and

**WHEREAS,** the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, pursuant to the Indian Reorganization Act of 1934; and

**WHEREAS,** Article V, Section 2(a) of the Ho-Chunk Nation Constitution ("Constitution") gives the Ho-Chunk Nation Legislature ("Legislature") the power to make laws, including codes, ordinances, resolutions, and statutes; and

**WHEREAS,** Article V, Section 2(b) of the Constitution grants the Legislature the power to establish Executive Departments, and to delegate legislative powers to the Executive branch to be administered by such Departments, in accordance with the law; any Department established by the Legislature shall be administered by the Executive; the Legislature reserves the power to review any action taken by virtue of such delegated power; and

**WHEREAS,** Article V, Section 2(d) of the Constitution grants the Legislature to authorize expenditures by law and appropriate funds to the various Departments in an annual budget; and

**WHEREAS,** Article V, Section 2(s) of the Constitution grants the Legislature the power to promote public health, education, charity, and such other services as may contribute to the social advancement of the members of the Ho-Chunk Nation; and

**WHEREAS,** Article V, Section 2(x) of the Constitution grants the Legislature the power to enact any other laws, ordinances, resolutions, and statutes necessary to exercise its legislative powers delegated by the General Council pursuant to Article III including but not limited to the forgoing list of powers; and

**WHEREAS,** the Legislature is authorized within the HCN Appropriations and Budget Process Act, § 7a(3), to appropriate funds identified by the Treasurer as Unexpended Funds from the previous fiscal year budget of the Nation; and

**WHEREAS,** the manner in which the Legislature appropriates such Unexpended Funds is discretionary and guided by the Legislature's general considerations of the needs and interests of the Nation under tribal law and the Constitution; and

**WHEREAS,** the Department of Business Whitetail Crossing wishes to purchase Veeder root tank gauges.

**NOW THEREFORE, BE IT RESOLVED** the Legislature, pursuant to its authority under the Constitution and the laws of the Nation, hereby authorizes and appropriates a portion of the previous Fiscal Year's Unexpended Funds as a discretionary payment for a true budget increase of \$1,200.00 to the minor equipment line item for each of the following C-Store locations; Black River Falls, Wittenberg, Nekoosa, Tomah and Baraboo; for a total amount of \$6,000.00 for the Department of Business Whitetail Crossing to purchase Veeder root tank gauges.

#### CERTIFICATION
