RESOLUTION 02-23-22 D

- WHEREAS,** on November 1, 1994, the Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and
- WHEREAS,** the Ho-Chunk Nation (“Nation”) is a federally recognized Indian Tribe, organized pursuant to the Indian Reorganization Act of 1934; and
- WHEREAS,** Article V, Section 2(a) of the Constitution of the Nation (“Constitution”) grants the Legislature of the Nation (“Legislature”) the power to make laws, including codes, ordinances, resolutions and statutes; and
- WHEREAS,** Article V, Section 2(b) of the Constitution grants the Legislature the power to establish Executive Departments, and to delegate legislative powers to the Executive branch to be administered by such Departments, in accordance with the law; and Department established by the Legislature shall be administered by the Executive; the Legislature reserves the power to review any action taken by the virtue of such delegated power; and
- WHEREAS,** Article V, Section 2(d) of the Constitution grants the Legislature the power to authorize expenditures by law and appropriate funds to the various Departments in an annual budget; and
- WHEREAS,** Article V, Section 2(i) of the Constitution grants the Legislature the power to negotiate and enter into treaties, compacts, contracts, and agreements with other governments, organizations or individuals; and
- WHEREAS,** the *Appropriations and Budget Process Act 2 HCC §4.6* states that “there shall be no true increases to a budget, except in emergency circumstances when it has been considered by the Legislative Finance Committee and approved by a two-thirds vote of the Legislature”; and

WHEREAS, the Legislature approved the 2020-2021 Fiscal Year Budget by Resolution 06-22-21 X Adoption of Ho-Chunk Nation Executive Branch Budget Bill for Fiscal Year 2021-2022 which provided funding for the Department of Social Services Child and Family Services Placement Assistance line item; and

WHEREAS, the Department of Social Services has identified that the Child and Family Services Placement Assistance line item is in need of additional funding for children in out-of-home placement and requests \$1,108,485.19 for the current budget deficit and the remainder of the 2021-2022 Fiscal Year; and

WHEREAS, Placement Assistance is provided to homes that care for Ho-Chunk children pursuant to the placement preferences set forth in Ho-Chunk Nation law, and must be adequately funded to assure that a sufficient number of such homes are available;

WHEREAS, at the February 9, 2022 Finance Committee meeting a motion was passed stating that the need for a true increase to the Department of Social Services Child and Family Services budget for Placement Assistance was an emergency and to refer the request to the Legislature for approval; and

WHEREAS, the Legislature recognizes the need and wishes to provide a true increase to the 2021-2022 Fiscal Year Budget for the Department of Social Services Child and Family Services Placement Assistance; and


WHEREAS, the Legislature adopted Resolution 02-23-22 A approving a true increase to the 2021-2022 Fiscal Year Budget for the Department of Social Services Child and Family Services Placement Assistance; and

WHEREAS, the Legislature wishes to rescind Resolution 02-23-22 A as the Department of Social Services Child and Family Services will be looking for funding for the Placement Assistance line item within the previously approved existing fiscal year budget;

NOW THEREFORE BE IT RESOLVED, that the Legislature of the Ho-Chunk Nation, pursuant to its Constitutional authority, hereby rescinds Resolution 02-23-22 A Approval of True Increase to Resolution 06-22-21 X Adoption of Ho-Chunk Nation Executive Branch Budget Bill for Fiscal Year 2021-2022 for the Department of Social Services Child and Family Services Placement Assistance.
