ASSOCIATION OF TRIBAL ARCHIVES, LIBRARIES, AND MUSEUMS  
AMERICAN RESCUE PLAN:  
HUMANITIES GRANTS FOR NATIVE CULTURAL INSTITUTIONS**

**RESOLUTION 02-14-23 F**

**WHEREAS**, on November 1, 1994, the Secretary of the Interior approved a new Constitution for the Ho-Chunk Nation, formerly known as the Wisconsin Winnebago Tribe; and

**WHEREAS**, the Ho-Chunk Nation ("Nation") is a federally recognized Indian Tribe, organized pursuant to the Indian Reorganization Act of 1934; and

**WHEREAS**, Article V, Section 2(a) of the Constitution of the Ho-Chunk Nation ("Constitution") grants the Legislature the power to make laws, including codes, ordinances, resolutions, and statutes; and

**WHEREAS**, Article III, Section 1 of the Constitution recognizes that the Nation possesses inherent sovereign powers by virtue of self-government; and

**WHEREAS**, Article V, Section 2(i) of the Constitution grants the Legislature the power to negotiate and enter into treaties, compacts, contracts, and agreements with other governments, organizations, or individuals; and

**WHEREAS**, Article V, Section 2(r) of the Constitution grants the Legislature the power to protect and foster Ho-Chunk religious freedom, culture, language, and traditions; and

**WHEREAS**, Ho-Chunk Nation Museum wishes to formally apply for the Association of Tribal Archives, Libraries and Museums - American Rescue Plan: Humanities Grants for Native Cultural Institution's grant funded by the National Endowment for the Humanities; and

**WHEREAS**, the application requires a letter of commitment from tribal leadership to participate in the project and this resolution serves as such a commitment; and

**WHEREAS**, if selected, the Ho-Chunk Nation Museum will be one of twenty-five (25) tribal entities and/or partners in the United States to receive support to help and assist with recovery from the COVID-19 pandemic and provide humanities programming to our communities; and

**WHEREAS**, if accepted, a matching funding commitment is not required; and

**WHEREAS**, the Ho-Chunk Nation Museum desires to strengthen its outreach services for Ho-Chunk history and knowledge keepers through educational programs that reflect Ho-Chunk Nation values; and

**WHEREAS**, the Legislature wishes to authorize the Museum and Cultural Center to apply for the Association of Tribal Archives, Libraries and Museums-Native Arts & Culture Council Pilot Project and express its commitment to participate in the project; and

**WHEREAS**, the Legislature adopted Resolution 02-14-23 D authorizing the Ho-Chunk Nation Museum to apply for the Association from Tribal Archives, Libraries and Museums - American Rescue Plan: Humanities Grants; and


**WHEREAS**, the Legislature wishes to rescind and restate Resolution 02-14-23 D to correct a typographical error in the resolution;


**NOW THEREFORE BE IT RESOLVED** that the Legislature, pursuant to its Constitutional authority, hereby rescinds and restates Resolution 02-14-23 D and authorizes the Ho-Chunk Nation Museum to apply and accept any award from the Association from Tribal Archives, Libraries and Museums - American Rescue Plan: Humanities Grants for Native Cultural Institution;

**BE IT FURTHER RESOLVED** the Legislature hereby authorizes the Vice-President to sign such documents on behalf of the Ho-Chunk Nation.
